**Explanation of Responses:**

1. Consists of 2,500,000 shares of Common Stock and shares issued and issuable under an aggregate of 333,485 restricted stock units ("RSUs"). Each RSU represents the right to receive one share of common stock upon vesting. The RSUs consist of (1) an award of 194,950 RSUs that vests as to 50% of the original number of RSUs on January 1, 2016, 33% on January 1, 2017 and 17% on January 1, 2018, (2) an award of 64,985 RSUs that vests as to 25% of the original number of RSUs on January 1, 2016, and as to an additional 25% upon the completion of each year thereafter, (3) an award of 42,755 RSUs that vests as to 25% of the original number of RSUs on January 1, 2017, and as to an additional 25% upon the completion of each year thereafter, and (4) an award of 30,795 RSUs that vests as to 25% of the original number of RSUs on January 1, 2018, and as to an additional 25% upon the completion of each year thereafter.

- 2. Fully vested.
- 3. This option was granted on January 23, 2015 and vests over four years, with 25% of the original 129,965 shares underlying the option having vested on January 1, 2016, and 2.0833% of the original 129,965 shares vesting monthly thereafter.
- 4. This option was granted on March 26, 2016 and vests over four years, with 25% of the original 85,510 shares underlying the option having vested on January 1, 2017, and 2.0833% of the original 85,510 shares vesting monthly thereafter.
- 5. This option was granted on January 31, 2017 and vests over four years, with 25% of the original 61,595 shares underlying the option vesting on January 1, 2018, and 2.0833% of the original 61,595 shares vesting monthly thereafter.
